FMF MULTI-DAY FAMILY INTERVENTION ESTIMATED COSTS

Phase I: Referral, Clinical Intake Consultation (CIC) & Pre-Intervention*:

Includes call with counsel, individual and conjoint intake meeting(s) with parents, and in some cases children, contact with relevant collateral sources, review intake questionnaires and relevant documentation, team consultation to accept/decline FMF intervention, additional communications with parents and counsel in preparation for the intervention

Hourly Rate: \$300.00/hour

Phase II: FMF Multi-Day Intervention (3 days at vacation location in Ontario):

Hourly Rate: \$250/hour per therapist (intervention is led by two co-therapists, one of whom conducted the CIC)

| • Preparation for intervention ~3-5 hours | \$750 - \$1,250 |
| • Travel and preparation day prior to intervention ~3 hours (2 therapists) | \$1,500 |
| • 8-15 clinical hours per day, per therapist for 3 days | \$12,000 - \$22,500 |
| • 3 rd clinician (3.5 days, includes day prior travel/preparation) | \$2,800 |

Estimated Total for Phase II: \$17,050 - \$28,050

Hotel Accommodations (2 parents and 2 children):¹

| • Clinicians' Meal (night before intervention @\$25) | \$ 75 |

*A retainer for the Clinical Intake Consultation will be required in advance of scheduling intake meetings. The intake clinician will advise the amount required for the initial retainer estimated on the basis of the family circumstances. Additional travel costs may apply for the intake and/or the multi-day intervention. Upon acceptance to the multi-day intervention, the parents will be advised of the retainer required estimated on the basis of the family circumstances (e.g., number, ages and gender of children, stepparent(s), new partners or other family member involvement). The full retainer is required within 48 hours of the family's acceptance. Fees apply for all services rendered from the initiation of the referral. Any unused retainer will be fully refunded. HST (and VAF taxes) are applicable for any non-therapeutic services (e.g. hotel, food, etc.). Any fees exceeding the retainer will be due upon receipt of invoice.

¹ In some cases, per availability and suitability, other accommodation may be used. Additional fees will apply for interventions involving more individuals.
