A Multi-Day Intervention for Separated Families When Children Resist Contact with a Parent

FMF MULTI-DAY FAMILY INTERVENTION ESTIMATED COSTS

Phase I: Referral, Clinical Intake Consultation (CIC) & Pre-Intervention¹

Includes: call with counsel, individual and conjoint intake meeting(s) with parents, and in some cases children, contact with relevant collateral sources, review of parent intake questionnaires and relevant documentation, team consultation to accept/decline FMF intervention, additional communications with parents and counsel in preparation for the intervention.

Hourly Rate: \$300.00/hour

- Estimated Intake hours ~6-15 hours \$1,800 - \$4,500
 - Administrative Fee \$200
- Estimated Total for Phase I:** **\$2,000 - \$4,700**

Phase II: FMF Multi-Day Intervention (MDFI) (~ 4 days, at vacation location in Ontario)²

Pre-Intervention Preparation @ \$300/hour:

- Coparent planning re MDFI; and, clinical interventions as needed and time permitting ~ 3-9 hours \$900 - \$2,700
- Program preparation for intervention ~3-5 hours \$900 - \$1,500

MDFI: @ \$250/hour per therapist (intervention is led by two co-therapists, one of whom conducted the CIC)

- Travel and team preparation ~4 hours (2 therapists) \$2,000
- 8-15 clinical hours per day, per therapist for 4 days \$16,000 - \$30,000
- Return Travel ~ 2 hours (2 therapists) \$1,000
- 3rd clinician (\$800/day, 4.5 days, includes half-day travel/preparation) \$3,600
- **Additional fees applied for written aftercare recommendations**

Estimated Total for Phase II: **\$24,400 - \$40,800**

Hotel Accommodations (2 parents and 2 children)³:

- 2-bedroom suite (for 1 parent & child(ren): ~\$650.00/day, 4 nights \$2,600
 - 3-bedroom suite or equivalent (for 3 therapists): ~\$1,050.00/day, 5 nights \$5,250
 - Single bedroom (for parent) ~ \$ 375.00/day, 4 nights \$1,500
 - Clinicians' Meal (night before intervention @ ~\$30) \$ 100
- Estimated Total for Accommodations:** **\$9,450**

TOTAL ESTIMATE: Phase I + Phase II + Accommodations: **\$35,850 - \$54,950**

¹A retainer for CIC is required before scheduling interviews. The intake clinician will advise the initial retainer required, estimated on the basis of the family circumstances. Travel costs may apply for the intake and/or the MDFI. Additional fees will apply for notification in writing when a family cannot be accepted for the MDFI. Upon acceptance for the MDFI, the parents will be advised of the retainer required estimated on the basis of the family circumstances (e.g., number, ages and gender of children, stepparent(s), new partners or other family member involvement). The full retainer is required within 48 hours of the family's acceptance. Fees apply for all services rendered from the initiation of the referral. Any unused retainer will be fully refunded. HST (& VAF) taxes applied to any non-therapeutic services (eg., hotel, food, etc.). Any fees exceeding the retainer will be due upon receipt of invoice.

² The MDFI may be suitable for 3 days and costs would be adjusted to reflect fewer days.

³ Costs can vary significantly depending on hotel and location. In some cases, per availability and suitability, other accommodation may be used. Additional fees may apply for interventions involving more individuals.
