- ❖ responding to initial queries & referral management
- ❖ intake, screening & conflict analysis
- ❖ informed consent & contracting
- ❖ consensus building phase: parent education, coparenting communication protocols, facilitation, management skills & parenting plans for high conflict coparenting
- ❖ arbitration phase: process, procedures, determining costs & writing awards
- ❖ summary of relevant case law

The training is interactive and includes group discussion, role plays, demonstration & a mock arbitration. Participants will develop practice skills and expand their tool kits to assist in their dispute resolution work with parents experiencing coparenting conflict and other challenges in effectively implementing their parenting plans post-separation.
